

President's Report

IWFTT 3rd fiscal year - A deeper understanding of our identity and confidently growing the Forum.

Our third year as the Trinidad and Tobago chapter of the International Women's Forum (IWF), much like a typical third-year of university or college, has been a time when our consolidated knowledge and growing confidence have been leveraged to produce marvelously accelerated results.

September 2016 - IWFTT conference, Chicago USA

We kicked off the fiscal year with the IWF Conference in Chicago, themed "Crossroads of Change".

Consistent with all IWF conferences, the plenary sessions were engaging and featured an impressive assortment of attendees, feature speakers, and panelists. Chicago, home of the first American female Nobel peace prize winner; Jane Adams was a fitting venue for a World Leadership Conference.

By the end of the conference, attendees seemed to share a clear desire to return to their professional lives, rejuvenated and re-committed to making a difference in their respective spheres of influence.

The Trinidad and Tobago IWF Chapter was represented by six members: Dr. Monica Davis, Patricia Kong Ting, Indu Sharma, Anya Schnoor and Gisele Marfleet.

<u>January 2017: Milestone Event – Induction of 12 new members to our Chapter</u>

Clearly the highlight of our year, January 2017 saw the chapter induct 12 additional highly accomplished women, to accompany the founding 20 that began the Forum in September 2014. Our new inductees have added to the Forum a wealth of experience, acumen in their respective fields, and the prestige of their individual accomplishments.

With the enlargement of the Forum comes an increase in energy—the compatibility and synergies between the two inductee classes being quite evident. We look forward to both individual and collective contributions by members of our Forum, which now numbers over thirty members from a variety of disciplines, such as the Energy Sector, Banking, Corporate and Entrepreneurial Business, Arts, Finance and Accounting, Media, Public Service, Education, Law, Public Relations, Occupational Therapy, Psychological Professional Services, Medicine, Fashion, Manufacturing, and Human Resources.

February 2017 - Discussion on Sexual Harassment held.

We had selected for discussion the topic of Sexual Harassment in the workplace and the issues surrounding same, as it was a current affair in the media. Our feature speaker was our new Sister **Teresa White**, HR Director for the Ansa McAl group of companies.

Teresa advised us about the importance of established sexual harassment policies in our work places, so that employees may be guided by the Company's documented accepted behavior in this regard. Members listened keenly to Teresa's sage advice as they received best practices to implement in their respective organizations.

April 2017- Discussion on Human Trafficking held.

In April 2017, we met for another Chapter meeting at the home of Sister **Karen Darbasie**. On this occasion, we selected the topic of Human Trafficking - another topic that dominated media attention and members wanted to find out more.

For this we were fortunate to have our own resident expert, namely, Sister **Charmaine Ghandi Andrews**, Chief Immigration Officer for Trinidad & Tobago. Charmaine spoke to us candidly and confidentially about the matter, citing examples of modern day indentured servitude and captivity of unsuspecting foreigners that come to Trinidad seeking a better life.

While members were comforted to know that there were competent protective forces in the Immigration Department to assist victims under Charmaine's stewardship, it was clear that members were startled at the inhumanity that can occur by predators on the vulnerable and defenseless.

May 2017- Cornerstone conference in Sweden

In mid-May, seven of our members travelled to Stockholm, Sweden for the Cornerstone Conference which featured the topic of "A more Sustainable World: Movements and Markets."

Moorjani. International guests were made to feel at home while appreciating the beauty and attributes of Sweden. Milestone - A new Executive Committee for a new term.

The office of Vice President, would remain vacant and elections would be held for the vacant position at the AGM in accordance with the by-laws of the IWFTT. Tiffany Reid was invited as a guest of the Executive meeting to assist the Committee in its activities.

Hosted by the Caribbean Corporate Governance Institute, of which Sisters **Jacqueline Quamina** and **Rani Narace** are Board Directors, the Symposium attracted a quality audience of female professionals in both public and private sector positions.

The event was well attended by women in all stages of their careers. This bodes well for Trinidad in developing its female professionals for more leadership positions. Philanthropic activity for 2017

On an initiative advanced by Sister **Patricia Kong Ting** at our last AGM, the Chapter chose to fund ten women to develop their literacy skills through ALTA for fiscal year 2017. The women were selected from seven different geographical ALTA locations in Trinidad. The annual cost of each student was \$600. We received progress reports on each of these women at the end of the academic year and these were very encouraging, with students making great strides. The ability to empower these women with reading and writing skills is a privilege. The Chapter can decide if they would like to continue supporting the program or chose another project instead.

Unilever Trinidad Ltd and retired at the end of July 2017 from the position of Managing Director, Unilever Caribbean Limited.

Sister **Jacqueline Quamina** will retire from Republic Bank Limited on September 15th, 2017 after a twenty-one year exemplary career in banking and legal counsel. Jacqueline was the first female Corporate Secretary, Group General Counsel and first female Executive Director of Republic Bank Limited.

Sister **Nicole Matouk** recently in July assumed the post of President of the Rotary Club of Port of Spain Central. Nicole's term of presidency is for one year. Nicole is the Joint Managing Director of National Canners Ltd.

We congratulate all of you on your accomplishments. You are inspiring!
